Behavior – We want the athletes to enjoy themselves and have fun at competitions! Comps should bring the athletes closer and help parents to bond. We do ask that you represent LSC in a positive light and be respectful to the competition staff and other teams/parents. Please be aware of your actions and words.

***Parents, please remain in the spectator area, or in front of the stage while the team is "on deck" to allow the team to focus before they perform.**

ATTENDANCE

Dance is a team sport that requires dancers to be at practice as much as possible to ensure the cleanliness and knowledge of the routine as a team.

You may not request an absence the week of a competition.

You will be allowed a total of 9 excused absences - 6 for dates given at least 2 weeks in advance and can be listed below, and 3 for day of sicknesses or emergencies.

RULES & FEES

It is completely unacceptable to miss a competition!

Dates are given months in advance & as this is a team sport it is required for the entire team to be at competition.

Fees for missing:

- \$250 for missing a competition
- \$25 for every 30 minutes the dancer is late to their call time at a competition
- \$25 Fee for leaving before end of award ceremony

Call time will be at least 2 hours before scheduled performance time so athletes can warm up and practice before taking the stage.

- Staff will only be available via the Band app on competition days.
- Performance times will be emailed out 2 weeks (at the earliest) before each competition.
- All dancers must stay for their awards ceremony.
- All dancers, parents, and staff will be respectful to each other, to other teams and the competition staff.

There will be 1 mandatory fundraiser for LSC, with \$150 profit or buy-out needed. All other fundraisers will go toward your personal account.

POLICIES & COMMITMENT

Autopay will run on the 10th each month for team installments.*

Autopay will run on the 25th each month for tuition.*

***There is a \$25 late fee for any payment not made within 5 days of the due date. A valid card will remain on file and will be recorded on the DocuSign agreement. Please contact us if you would like an alternate payment arrangement.**

I am financially responsible for the entire season. Fees are not refundable. Any bank chargeback or returned payment will acquire a fee.

If I drop mid dance season, I am still responsible for my remaining bill which must be paid off by the drop date,

If I fall behind on my bill more than 2 months, I will receive up to 2 notices before action will be taken to remove my athlete from a competition, event or practices. I understand that I will not be able to perform in a competition or event if my bill is behind.

I am responsible for reading and abiding by the Parent Portal policies.

I am required to sign the DocuSign agreement of this packet to be on the team.

I will be kind and respectful to all athletes, team members, parents, LSC staff and other LSC families. I am representing LSC and will be cautious with my words and actions. There is no tolerance for gossiping, negative talk or loud/inappropriate language in the gym, at competitions, on apparel, and in group chats.

I understand that I must text the team group chat if dancer will be missing or late to practice.

I understand that I will not get makeup tokens for missing practice.

I will inform Sheree or LSC staff as soon as there is a concern or issue so that it is easier to come to a solution or agreement.
